The OSU Environmental Health and Safety Department presented a 4-hour continuing education OSHA *Trenching Safety Course* at the Southwestern Vo-Tech located in Altus Oklahoma. The course audience consisted of 55 municipal and county equipment operators, field management, volunteer first-

responders, safety and emergency personnel. Jerry West presented a 45-minute presentation on *Excavators Responsibilities* and Oklahoma One-Call Law. Chesapeake Midstream followed the presentation with information regarding pipeline safety.

ODOT Pre-Construction Roundtable

Call Okie hosted a Pre-Construction Roundtable meeting with 62 attendees representing contractors, ODOT inspectors, utility members and contract locating services. The meeting was held at the ODOT Training Facility located at I-35 and SE 59th street in OKC. Alan Stevenson, ITS/Fiber Optics Engineering Manager, shared maps outlining ODOT's current 8-Year Construction Work Plan as well as efforts to install 1,000 plus miles of fiber optic line. The discussion offered new opportunities for members and ODOT to coordinate survey request and locating issues to help minimize down time

and cost associated for these statewide projects. Following the meeting contractors and utility/line locators were encouraged to communicate and exchange contact information. The committee requested additional meetings to communicate ongoing changes to the projects.
